 puppies to know how to walk on a leash and pull -We need the dogs to know basic manners, sit,
 laydown, leave it.
- All studs should be friendly with any dogs, including males. All females should be friendly to all dogs and people

Vet information:

- Puppies need to have their age appropriate shots (at 15 weeks they need their final booster)
- Monthly deworming
- 6-month rabies' shots (and then either yearly or twice a year after that)
- Yearly boosters for parvo and kennel cough
- Yearly check ups
- Flea and tick preventative
